A RESOLUTION OF THE BOARD OF TRUSTEES OF THE BEDFORD FREE LIBRARY

WHEREAS, there has been presented to the Board of Trustees of the BEDFORD FREE Library a petition signed by more than twenty-five qualified voters of the Town of Bedford, asking that the following question be placed upon the ballot and voted on at the next general election of the Town of Bedford:

NOW, THEREFORE, BE IT RESOLVED, that this Board of Trustees hereby endorses the petition presented to it and directs that the following question be voted on at the next general election of the Town of Bedford:
